1. Exhibitor will occupy space in the exhibit hall during the designated dates and time frames.
2. Promotional Materials, collateral or act activities must be confined within the limits of the exhibitor's purchased space.
3. Exhibitor agrees to pay for the total cost of the booth as noted on the application. Exhibit space may be reserved with 50% deposit. Remaining cost must be paid no later than March 2, 2018. If Exhibitor does not make payment when required, SCNA may offer the Exhibit space to others.
4. The exhibitor has until March 2, 2018 to cancel and receive a refund, minus \$100 cancellation fee. There will be NO REFUNDS PROVIDED for cancellation after March 2, 2018. If the SCNA cancels the conference due to inclement weather or any other event beyond its control, SCNA will provide exhibitor with a credit toward exhibit space at a future SCNA conference. The amount of the credit will equal the amount paid by the exhibitor up to the date of cancellation.
